## **City Superintendent Report**

City Superintendent Julius Windholz gave his department report. The new lawn tractor has been delivered and the one recycling trailer is being modified for the cities use and the other has been ordered with the recyclables being taken to Hays.

#### **Police Department Report**

Police Chief Cole Dinkel gave his department report. A new windows program will need to be purchased for the police computers for them to be able to run the programs that are compatible with the county. Consensus of the council was to go ahead and purchase the software that is needed. Rural Telephone also submitted a quote for the new camera to replace the one at the compost site. Chief Dinkel will negotiate the price with Rural Telephone.

### **Additional Street Lights**

There are several areas that are not very well illuminated for citizens when they are walking after dark. The city will request additional street lights from Midwest Energy added at 13th and Cathedral and under the railroad bridge. There was some discussion on the safety of not being able to see headlights approaching. The police will work with Midwest Energy on the placement of the light around the railroad bridge.

## Recycling

There have been requests from residents outside city limits to use the recycling trailers. Consensus of the council was to only allow use of the recycling trailers by Victoria residents who live in the city limits.

#### **Scanner Purchase**

There have been times when the use of a scanner at city hall would have been useful. City Clerk Mary Pfeifer will have prices for the next meeting.

#### **City Street Flower Pots**

Det Younger has a group of citizens that will be willing to take care of the street planters for the summer. Council was very appreciative that they would be willing to take care of the pots. The city will purchase the plants.
