Tree Removal

Keith Engweiler proposed a plan to eliminate the need for the removal of a tree located on his property when the street and gutter improvements are made to Iron Street. After consideration of the plan and discussion, it was the consensus of the council that the tree would still have to be removed to avoid further damage to the street and curbing once it had been replaced.

Outdoor Basketball Court

Shannon Radke with the Victoria Recreation spoke with council about the possibility of constructing an outdoor basketball court. The parking lot at the city park or the baseball park were two sites that had been suggested. Radke is going to approach the school board to get input from them and proceed from there. The city council expressed interest in the project.

Ken Beran with Adams, Brown, Beran and Ball reviewed the 2013 budget. The mill levy for 2013 will be at 46.098. Expenditures for 2013 will be at \$1,061,114.

City Superintendent Report

City Superintendent Julius Windholz gave his department report. The street project should be starting August 27, 2012. The roof on the garage located at 1007 Hickory needs to be replaced. Consensus of council was to replace the roof with metal. There was considerable discussion on the how the water wells are holding up. Most of the wells are being stressed. The Stage 2 Water Warning was reviewed, it includes only allowing outside watering for odd numbered addresses on Tuesday and Saturday. Even numbered addresses will be allowed to water on Wednesday and Sunday. Watering on those days will be allowed from 5 am until 10:00 am and 9:00 pm until midnight. Additionally, excess water use charges for usage of water over the amount used in the winter will be imposed. That amount was set at an additional 0.60 (sixty-cents) per thousand gallons of water. Motion by Leroy Schmidtberger, second by Jerry Brungardt to implement a Stage 2 Water Warning for the City of Victoria until further notice.
