Warrant Ordinance A-09-11

City Superintendent Report

City Superintendent Julius Windholz gave his department report. Windholz has found a snow blower for around \$500. Motion by Leroy Schmidtberger second by Jan Piesker to purchase the snow blower for around \$500.00. Barricades will run about \$80 a set and Windholz would like to purchase 6 sets. A catwalk for one of the recycling trailers will be donated by Jeff Crawford and Windholz will have a ramp welded to the catwalk. The waterline locator is going out and a replacement will cost around \$2600.00. Motion to approve the purchase of a new locator for \$2600.00 by Jerry Brungardt, second by Kenneth Pfeifer.

New Construction Billing

Councilmember Brungardt questioned the policy of utility billing for new construction. Motion by Jerry Brungardt, second by Leroy Schmidtberger to suspend water, trash, and sewer billing until a final inspection has been done.

Street Repairs

Street repair estimates were reviewed. Council would like to see more current estimates and take the opportunity to drive around and see which streets are in the most need of repair.

Police Department Report

Police Chief Cole Dinkel gave his department report. The price for new duty gear would run around \$300 and under per person. Consensus of the council was to purchase new duty gear for each officer. The part-time help the police department used will no longer be available. Chief Dinkel will check with the Hays Police Department to see if there would be anyone available to work when the city needs a fill in. The police department would like to have an open house for council after the next meeting. Council would like to consider having an open house for the entire city sometime next year. Chief Dinkel has spoken with the individual who has the barking dog and they are going to try to work on the problem.

Ordinance B-524

AN ORDINANCE AMENDING SEC. 9-308 OF CHAPTER IV, ARTICLE III, OF THE CODE OF ORDINANCES OF THE CITY OF VICTORIA, KANSAS, AS AMENDED BY ORDINANCE B-474, AS PASSED ON FEBRUARY 21, 2005, AND AS PUBLISHED ON FEBRUARY 25, 2005, BY PROVIDING FOR AN INCREASE OF GARBAGE AND/OR RUBBISH COLLECTION RATES IN THE CITY OF VICTORIA, KANSAS.
