## **City Superintendent Report**

City Superintendent Julius Windholz gave his department report. Council would like to have Windholz get in touch with Albert Reed on treating the water wells. Windholz gave an estimate of \$23,000.00 for chip and sealing several streets with the county help. Motion by Jerry Brungardt, second by Jan Piesker to go ahead with the street chip and sealing for an estimated cost of \$23,000. Windholz questioned who is allowed to use the burn pile and consensus of the council was it is to be used by city residents only.

## **Police Department Report**

Police Officer Ryan Mauch gave the police department report. Council asked about water violations and there have been warnings issued but at this time no tickets.

## **Fireworks**

Fireworks will not be allowed to be discharged within the city limits on July 4.
