#### **Ordinance B-559**

AN ORDINANCE AMENDING ORDINANCE B-537 AS PASSED BY THE GOVERNING BODY OF THE CITY OF VICTORIA KANSAS ON OCTOBER 21, 2013, BY AMENDING USER CHARGE RATES IN THE CITY OF VICTORIA, COUNTY OF ELLIS, STATE OF KANSAS, TO PROVIDE FUNDS NEEDED TO PAY FOR EXPENSES ASSOCIATED WITH THE CITY'S WASTEWATER TREATMENT WORKS, AND BY AMENDING APPENDIXES "A" AND "B" TO ORDINANCE B-537.
