Minutes of the June 18, 2018 regular meeting were presented for review. Motion by Dustin Schumacher, second by Ryan Lichter to approve the minutes as submitted. Vote: 5 Ayes 0 Nays, Motion declared carried.

Warrant Ordinance A-07-18

Ordinance A-07-18, consisting of bills against the City for the month of June was presented for review. Motion by Zach Kanzenbach, second by Dustin Schumacher that Ordinance A-07-18 be approved and all bills paid.

Motion by Erica Dinges, second by Harland Rupp to approve the agenda with modifications of Herzogfest helicopter and pit bull discussion.

Police Department Report

Police Chief Cole Dinkel gave his department report. Chief Dinkel will compile a list of properties that need letters concerning dilapidated buildings. It will be sent to Council to give them time to drive by the property and they will be discussed at the next council meeting. Chief Dinkel also showed Council the body cameras that were purchased.

City Superintendent Report

City Superintendent Brad Schmidtberger gave his department report. Well #13 is down and Schmidtberger solicited a bid for repair from Sargent Drilling. Council would like to see an additional bid before making a final decision. Motion to pay T&J Construction \$1,800.00 for repairs to streets where Kansas Gas Service repaired their lines by Harland Rupp, second by Ryan Lichter.

Grow Hays Representative

Ivan Werner served as the City representative for the Ellis County Coalition for Economic Development. He no longer wishes to serve on the board. It has been renamed Grow Hays and the board number has been cut to 5 people. Grow Hays still wishes to have a representative from Victoria on the board and Werner feels it would be good for the City to have a representative. Councilmembers will try to find someone to replace Werner and bring his/her name to the next city council meeting.

Helicopter Landing

Council member Kanzenbach questioned whether or not it would be a good idea to have a helicopter land in the swimming pool parking lot during the Herzogfest. After some discussion Council agreed it would be better to find another place for the helicopter to land.

Herzogfest Lease Agreement
