Charter Ordinance No. 13

The City Clerk was directed to publish the Charter Ordinance once a week for two consecutive weeks in the official City newspaper, and shall take effect sixty (60) days after final publication, unless a petition signed by a number of electors of the City equal to not less than ten percent (10%) of the number of electors who voted at the last preceding regular City election shall be filed in the office of the City Clerk.

Resolution C-303 pertaining to the official intent of the City to undertake a certain project, finance the same with General Obligation Bonds of the City and be authorized to apply proceeds of such bonds to certain original expenditures on such project was presented for council approval.
