Options Donation

Andrea Cross Development Director with Options was present at the council meeting, as well as board member Erin Rupp. They are celebrating 40th Anniversary of being a non-profit organization. Statistics were presented and different costs of funding the program. They are working with the Hays Police department, Johnson County and Wichita on developing a lethiality exam. She informed Chief Dinkel if they wanted to partner with them, they are welcome to. Information regarding domestic violence and domestic murders was

presented. They now have a domestic violence helpline with a mobile advocacy.

**Grow Hays** 

James Robben with Grow Hays attended the council meeting. He gave the updated report of the NRP. There will be a letter in ordinance form sent to Attorney Don Hoffman regarding the City of Victoria adopting the NRP, Neighborhood Revitalization Plan. James will return to the July meeting with the final report for approval by the City Council. He also

asked for a Funding Request of \$3,000.00 for 2024, for E-Community loans.

**Police Report** Police Chief Cole Dinkel gave his department report. He had no requests at this time.

Chief Dinkel stated summer is as normal. He has sent out several letters regarding mowing, and tree trimming to residents. He reported there is still no word on the new pickup for the

Police Department.

# Report

City Superintendent Brad Schmidtberger gave his department report. He stated the meters Superintendent have shipped to finish the last wells. He will contact Downey Drilling to install these. Brad informed council the State of Kansas has had many cyber attacks. Brad has been in contact with INR regarding the cameras. The City may have to set our own poles to install cameras on. It was brought up to supplement these cameras with solar cameras. The lift station is a concern. He stated it is still functioning but getting old. The major concern is that the pit is rusting. Ryan Lichter made a motion to get a new lift station, second by Erica Dinges.

City Superintendent also brought up purchasing supplies for the water and sewer main extentions for the new Dollar General. Motion by Matt Sander, second by Harland Rupp to allow up to \$250,000.00 for supplies.

Fire Chief John Weber gave his department report. Chief Weber informed the council regarding a grant for new hoses for the fire trucks. There is a Fire Fighter from Hays that is helping write the grant. The City Council approved paying 10% for the hoses at the May meeting. The amount is around \$25,194.00 and City's responsibility would be \$2,519.00. Motion by Erica Dinges, Second by Matt Sander to approve the amount.
