While the name on the office door now reads Simons Tax & Accounting, the legacy of Allen Dreiling as the prior owner remains a definite part of the new business. New owner Derek Gerstner says one of his goals in purchasing the firm was to 'keep the traditions' that Dreiling and long-time employee Paul Lang built over the years. Gerstner officially took over in early November. In addition to the services Dreiling provided his clients, Gerstner says they now will add some new things on the investment side.

Reasons for wanting to become a part of the Victoria business community include the fact that his family has ties to the community and that he was very familiar with the work Dreiling and Lang were known for. Years ago, when they moved to electronic processing, Gerstner was the computer guy who got them up and going. He says the relationship they

Friendly Reminder



It's that time again! The deadline for registering your pets at City Hall is March 1. Both dogs and cats require tags. Cost for spayed/neutered animals is \$2.00 if purchased before the deadline. A current rabies immunization must be presented at the time a tag is issued. After that deadline, a late fee of \$1.00 per month is assessed. Owners whose pets are not licensed run the risk of a \$50 fine if their pet is picked up without a tag.

Hoisington Veterinary Service to visit Feb. 25

Members of the Hoisington Veterinary Clinic will bring their mobile unit to Victoria on Saturday, Feb. 15 from 9:00-11:00 a.m. They will be set up at City Hall.

Their staff members will be able to give all shots and also do short exams if time allows. City Hall has a complete list of prices for shots, microchips, etc. If anyone has questions, they can call Jess at (620) 653-2862 for more information.

Citizens will also be able to purchase their city pet tags at the same time.

New ordinance allows for ATV/UTVs

The City of Victoria and the Victoria Police Department are happy to announce the passage of a new ordinance allowing on-street use of ATVs and other utility vehicles that would normally not be allowed under Kansas State Traffic Ordinance laws. The urge to approve this ordinance came from a number of citizen requests. In years past, the City has only allowed these vehicles to be driven on city streets when being used for things such as snow removal and yard spraying.

As of January 1, 2017, citizens and area residents may apply for a City of Victoria ATV registration at City Hall. A simple form must be filled out by the owner of the vehicle, who must be 18 years old. If the owner is underage, the parent or legal guardian must complete the form. Please have your driver's license, along with those of any other household member who may be operating the vehicle at any time. Also required is a copy of current insurance coverage on the vehicle as well as ownership documentation if available. This could be a bill of sale or the actual title. A \$25 registration fee is required with the application.

Once the application and documentation are complete, City Hall will then contact a Victoria police officer to inspect the vehicle. Please DO NOT drive the vehicle to City Hall. The vehicle is not legal until the inspection is passed and a decal is displayed.

Operators under the age of 18 may only operate a legally registered ATV/UTV on city streets if they have a graduated driver's license. The ordinance does NOT permit restricted drivers nor those with learners' permits or farm permits. Drivers must be 16 1/2 years old or older. All juvenile operators and passengers must wear helmets, no matter what type of ATV/UTV they are riding. Eye protection is also a must for everyone. The only substitutes for eye protection are a full-face helmet or a windshield that covers as high as the top of the tallest rider's head.

All legal ATV/UTVs must be equipped with headlights, taillights and brake lights. At least one rearview mirror must be mounted on the vehicle. No ATV/UTV will be permitted on city streets after dark. No ATV/UTV will be permitted on any highway, including Highway 40, Interstate 70 and Highway 255 (Cathedral St. from 13th to I-70). ATV/UTVs may only cross highways at a 90-degree angle.

If violations are committed, the owners and operators will be cited. All traffic laws must still be obeyed, the same as operating a car or pick-up. Keep in mind that this is a trial year for this ordinance. If peace and /or property are compromised, it is possible this privilege may be revoked. This ordinance is a great addition to the many benefits of living in Victoria, so operators are asked to be respectful of the rules.

We also ask that everyone be on the lookout for these vehicles. They are small with few safety features. A collision with a car or pickup could be deadly. Please be safe and have a happy new year!
