## ORDINANCE NO. B-552

AN ORDINANCE AMENDING ORDINANCE B-531, OF THE CODE OF ORDINANCES OF THE CITY OF VICTORIA, KANSAS, AS ADOPTED ON DECEMBER 21, 2012, BY PROVIDING FOR AN INCREASE OF WATER RATES INSIDE THE CITY OF VICTORIA, KANSAS, AND BY PROVIDING FOR AN INCREASE OF WATER RATES OUTSIDE THE CITY OF VICTORIA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF VICTORIA, KANSAS:

<u>Section 1.</u> Ordinance B-531, of the Code of Ordinances of the City of Victoria, Kansas, as adopted on December 21, 2012, is hereby amended to read as follows:

Sec. 15-221. WATER RATES. All water sold by the City to regular customers shall be on a metered basis. The rates to be charged therefore shall be as follows:

## INSIDE CITY LIMITS

A minimum charge of thirty-two dollars (\$32.00) for the first two thousand gallons (2,000 gals.) each month.

In addition to the above charge of thirty-two dollars (\$32.00) for the first two thousand gallons (2,000 gals.) each month, thereafter, the charge for water usage in excess of two thousand gallons (2,000 gals.) per month shall be as follows:

- A. Two thousand one gallons (2,001 gals.) to four thousand gallons (4,000 gals.) will be eight dollars (\$8.00) per thousand gallons.
- B. Four thousand one gallons (4,001 gals.) to six thousand gallons (6,000 gals.) will be thirteen dollars (\$13.00) per thousand gallons.
- C. Six thousand one gallons (6,001 gals.) to eight thousand gallons (8,000) will be eighteen dollars (\$18.00) per thousand gallons.

- D. Over eight thousand one gallons (8,001) and over will be Twenty-three dollars (\$23) per thousand gallons.
- E. The above charge shall be applied cumulatively less the base of two thousand gallons (2,000 gals.). For example, if the customer uses 8,000 gallons of water for the month, the charge will be Eighteen dollars (\$18) per thousand gallons plus the base charge of thirty-two dollars (\$32) for two thousand gallons (2,000 gals.). The bill would be (8,000-2,000) 6,000 or 6 x \$18.00 (\$108) + \$32 = \$140.

## OUTSIDE CITY LIMITS

A minimum charge of sixty-four dollars (\$64.00) for the first two thousand gallons (2,000 gals.) each month.

In addition to the above charge of sixty-four dollars (\$64.00) for the first two thousand gallons (2,000 gals.) each month, thereafter, the charge for water usage in excess of two thousand gallons (2,000 gals.) per month shall be as follows:

- A. Two thousand one gallons (2,001 gals.) to four thousand gallons (4,000 gals.) will be sixteen dollars (\$16.00) per thousand gallons.
- B. Four thousand one gallons (4,001 gals.) to six thousand gallons (6,000 gals.) will be twenty-six dollars (\$26.00) per thousand gallons.
- C. Six thousand one gallons (6,001 gals.) to eight thousand gallons (8,000 gals.) will be thirty-six dollars (\$36.00) per thousand gallons.
- D. Over eight thousand one gallons (8,001 gals.) and over will be forty-six dollars (\$46) per thousand gallons.
- E. The above charge shall be applied cumulatively less the base of two thousand gallons (2,000 gals.). For example, if the costomer uses 8,000 gallons of water for the month, the charge will be thirty-six dollars (\$36) per 1,000 gallons plus the base charge of

sixty-four dollars (\$64) for two thousand gallons (2,000 gals.). The bill would be (8,000 gals.-2,000 gals) \$6,000 gallons or  $6 \times $36$  (\$216) + \$64 = \$280.

<u>Section 2.</u> Ordinance B-531 of the Code of Ordinances of the City of Victoria, Kansas, as adopted on December 21, 2012, is hereby repealed.

Section 3. This ordinance shall take effect on  $\frac{\text{June 20}}{\text{and after its publication in the Russell County News, the official city newspaper.}$
